

RESOURCE GUIDE FOR CLERGY

In at least one in four families... in any congregation... of any religion or sect... a woman is being abused. More than 25% of teenagers are physically assaulted each year. Men, though batterers more than 95% of the time cases are reported, are sometimes victims as well.

Domestic violence or relationship abuse is all about power and control: it has nothing to do with love. The victim is terrified into submission. Hopefully some of your congregants will find the courage to come to you. With gentle encouragement you can uncover the true reason for a visit about family discord. Where can an abused woman get domestic abuse counseling?

Where can children and teens get counseling and support?

Where can batterers be referred for counseling?

Domestic violence is about battering – not anger management. The batterer must take responsibility for his/her actions before being accepted into a program.

IMPACT **980-721-7268**

Court or self-referral batterer intervention: 26 weeks. Men only. Fee based.

NOVA **704-336-4344**

Court and provider referred (churches included) batterers intervention: 26 weeks.
Men, women and Spanish-speaking groups. Fee based.

LEGAL SUPPORT

Why, when and how would one get a restraining order?

If the victim has been physically assaulted or threatened with bodily harm, they can file for a restraining order. For help contact:

Helps with filing papers for an emergency restraining order, accompanies to court for all hearings, advocates on behalf of victims. Free.

To obtain an attorney for a hearing on a one-year restraining order. Free, if accepted.

CRIMINAL JUSTICE SYSTEM

How does one take out a warrant to have the abuser arrested?

A police report is required. If you don't already have one, call 311. Take the police report to the
*Magistrate's Office and ask for a warrant.

Victim Assistance 704-336-4126
Will help follow the case as advocates and will accompany to court if contacted
by victim.

District Attorney's Office 704-347-7891
Handles the victim's side of the case. Will be able to answer questions regarding
criminal charges and court dates and times.

HOUSING

Where can a woman and her children go in an emergency?

Residential care including counseling, case management and transitional services.

MEDICAL

Will an abused woman find help at a hospital?

forensic nurses) and information and referral services.
